## Convention Mailing #2 - Chorus

- **Watch Your Membership Roster – All members competing on the regional stage must be listed on each chorus' membership roster on April 29<sup>th</sup>.** You must be sure that all new members and all renewals are processed through Tulsa no later than April 29<sup>th</sup>. If a chorus competes with a member not appearing on their membership report, the chorus could be disqualified. Chapter leaders may access their membership reports through International's website. If you have questions about this, please ask.
- **Video Process** – Your video must be in an mp4 format. This is the ONLY acceptable format. All videos will be uploaded to the Region's Drop Box. We will be sending each chorus an email with instructions and a link in mid-April. The link will only give you access to your chorus's folder. You will not be able to access any other contestant's folder. Your video must be uploaded by 5:00 pm (Central) on May 9<sup>th</sup>.
- **List of Competing Member Verification Form** – This form is required for all choruses. Only the attached form will be accepted. Please list your director first followed by all members alphabetically. Once you have typed all the names into the form, print out the form and have each member sign the form. Please type the names to ensure we can approve all the members listed. The form is due May 1<sup>st</sup>. Please mail or email to Shelly Hughes. A scanned copy or photocopy is fine. Choruses should retain the original.
- **Song Information Sheet** – This form provides us with your competition song information – this is new this year. The form is due May 1<sup>st</sup>. Please mail or email to Shelly Hughes.
- **Video Broadcast** – All submitted videos will be played during the Virtual Convention. If your chorus would like to opt-out of the Virtual Convention, please email Shelly Hughes no later than May 9<sup>th</sup>.
- **Virtual Convention** – The Virtual Convention will broadcast Saturday, May 21<sup>st</sup> starting at 9:00 am (Central). Here is the line-up:
