## Convention Mailing #1

Hello all and welcome to the 2022 Video Convention.

Forms are no longer included within the mailing – they are separate attachments. All forms are fillable pdfs and only these forms will be accepted.

### CONVENTION INFORMATION

- **Convention Mailings** – This is the first of two mailings. This one is designed for all members and the next one is for competitors only. The second mailing will be sent when we receive notice that your chorus or quartet has registered for competition. The second mailing will focus on all the competition forms. Copies of all the mailings and forms will be available on the region's website - [www.region3sweetadelines.org](http://www.region3sweetadelines.org).
- **Registration** – An All Events order form is attached and available on the region's website. An All Events is required for all competitors and includes admittance to the Virtual Convention. Virtual Convention tickets for your guests and non-competing members are also available.

All Events cost is \$75 and Virtual Convention only tickets are \$25. Form and payment is due April 1, 2022. All that register will receive a link to the virtual convention. All purchases are transferable, but not refundable.

- **Competition Deadlines** – International Headquarters will email competitor packets to all choruses and quartets on January 28, 2022. The packets are available on International's website now.

**Quartets:** Competition entry deadline is March 14, 2022 (late entry is March 29, 2022 and will incur an extra fee). Entries after March 29<sup>th</sup> will not be processed.

**Choruses:** Competition entry deadline is March 15, 2022 (late entry is March 30, 2022 and will incur an extra fee). Entries after March 30<sup>th</sup> will not be processed.
